

Executive Director's Report



As I write this introduction and reflect upon this past year, my thoughts overwhelmingly are of sincere gratitude for your support. The McHenry County community continues to show up for one another every day. It's simultaneously heartwarming and heartbreaking to see all of the needs we can meet due to the donations The United Way of McHenry County receives and the programs that are strengthened and accessible because of them. New challenges continue to present themselves in this post-pandemic world, but collectively, we are up to facing them arm-in-arm with our supporters and partners.

Undoubtedly, we are strongest when we work together, and collaboration is an area where McHenry County continues to shine brightly. Our grant support of 50 programs results in over 1 in 4 residents being able to receive the help they need, whether it be critical life-saving programs like free and reduced-cost healthcare, mental health care, emergency housing, shelter from abuse, and food for their table, or critical life-enhancing programs like access to early childhood education and affordable childcare, advocacy, mentors, and volunteer help for seniors. Chances are very high that you or someone you know has positively impacted their life from the programs we support.

Since January of 2022, we have also been running our program that increases food security access. Ride United enables food pantries to offer free deliveries to ensure that transportation and physical challenges do not prevent anyone in McHenry County from being secure in their next meal. Our 2-1-1 helpline is available 24 hours a day to ensure that when help is needed, it can be found. The United Way of Greater McHenry County is here to improve lives, and we are grateful for what you have done this past year and continue to do to help.


